

Terms of Service

Last Modified: February 17, 2026

These Terms of Service, including any policies, rules and other documents that are expressly incorporated herein by reference (collectively, the "Terms"), sets forth a legally binding agreement between you and Aureon Care, LLC ("Aureon Care", "we", or "us"). These Terms govern your access to and use of any Aureon Care websites, applications, software, products and services that link to these Terms, including the Aureon Care mobile application (the "App") and the website located at aureon.care (the "Site"), and any content, information, features, capabilities, functionality, products and services offered on or through the App and the Site (collectively, the "Services"), whether as a guest or a registered user. Please read these Terms carefully before accessing or using the Site or any Services.

ARBITRATION NOTICE: THESE TERMS CONTAIN A BINDING ARBITRATION CLAUSE (SECTION 22) AND CLASS ACTION WAIVER (SECTION 23) THAT WAIVE YOUR RIGHT TO A COURT HEARING AND JURY TRIAL. PLEASE READ THEM CAREFULLY.

1. Acceptance of Terms

By using any of the Services (whether or not you have an Aureon Care account or Subscription (as defined below) to any particular Services), or by clicking to accept or agree to these Terms when this option is made available to you, you accept and agree to be bound by these Terms and to abide by all applicable laws with regard to your use of the Services. Except as specified herein, these Terms apply to any use of the Services, including, without limitation, when you: (i) interact with us on or through the App and/or the Site; or (ii) create and use an Aureon Care account. In order to use the Services, you must first agree to these Terms. If you do not agree to be bound by these Terms and to abide by all applicable laws, you may not use any of the Services. In addition to these Terms, your use of certain Services may require you to accept additional terms and conditions applicable to such Services, including any additional terms and conditions applicable to Subscriptions (collectively, "Additional Terms"). When using particular Services, you shall be subject to any rules or policies applicable to such Services that may be posted or made available to you through the Services from time to time ("Aureon Care Policies"). The Additional Terms and Aureon Care Policies are incorporated and made a part of these Terms by this reference.

2. Changes to Terms

Aureon Care reserves the right, at its sole discretion, to change, modify, update or supplement these Terms or any Additional Terms that apply to a Service, at any time, including to reflect changes to the law or changes to our Services. When these changes are made, Aureon Care will make a new copy of these Terms available on the App and the Site, and any Additional Terms will be made available to you from within, or through, the affected Services. All changes are effective immediately when we post them or make them available to you, and apply to all access to and use of the Services thereafter. You

acknowledge and agree that if you use the Services after the date on which these Terms have changed, Aureon Care will treat your use as acceptance of the updated Terms. It is your responsibility to check these Terms periodically for changes. Your continued use of the Services following the posting of any changes will mean that you accept and agree to the changes. If any changes are unacceptable to you, you may stop using the Services and, if applicable, cancel your Subscription.

3. Privacy Statement

When you access the App or the Site or use any of the Services, you provide us with different types of information. Please read our Privacy Statement which explains how we collect, use and share information through the App, the Site and the Services, as well as your choices regarding these activities. The Privacy Statement applies to use of the App, the Site and the Services, and its terms and conditions are hereby incorporated into and made a part of these Terms by this reference.

4. Eligibility to Use the Services

The Services are intended for adults in the United States. You may not use the Services if you are (i) not of legal age to form a binding contract with Aureon Care or (ii) barred from receiving or using the Services under the laws of the jurisdiction in which you are resident or from which you use the Services. By using the Services, you represent that you satisfy the requirements set forth herein. You must be at least 18 years of age to purchase or use any Services.

5. Account Creation

You may need to create an Aureon Care account in order to access and use the Services. To protect your Aureon Care account, please keep your username and password strictly confidential. You are solely responsible for maintaining the confidentiality of your username, password and other account information, and are fully responsible for all activities performed through use under your Aureon Care account. If required, you will create a username and password for your Aureon Care account. You must provide accurate, complete and current registration information when you register and create an Aureon Care account. In consideration of your use of the Services, you agree to: (i) provide true, accurate, current, and complete registration information about yourself as prompted by the Service; and (ii) maintain and promptly update the registration information to keep it true, accurate, current and complete. If you provide any registration information that is untrue, inaccurate, not current or incomplete, Aureon Care has the right to limit, suspend or terminate your account and your access to the Services (or any portion thereof). You agree to immediately notify Aureon Care of any unauthorized use of your Aureon Care account and ensure that you exit from your account at the end of each session. Aureon Care will not be liable for any damages arising from your failure to comply with this Section.

6. Subscriptions

You may purchase access to certain Services and Aureon Care Content on a subscription basis (“Subscriptions”). Subscriptions automatically renew as set forth below until cancelled in the subscription settings section of your Aureon Care account page. We will notify you if the price of a Subscription increases and, if required, seek your consent to continue. You will be charged no more than twenty-four (24) hours prior to the start of the latest Subscription period. If we cannot charge your payment method for any reason (such as expiration or insufficient funds), and you have not cancelled the Subscription, you remain responsible for any uncollected amounts, and we will attempt to charge the payment method as you may update your payment method information. This may result in a change to the start of your next Subscription period and may change the date on which you are billed for each period. Aureon Care reserves the right to cancel your Subscription if we are unable to successfully charge your payment method to renew your Subscription. When your Subscription ends, you will lose access to the Services and Aureon Care Content that require a Subscription.

Prices and Refunds

For Subscriptions, you will be charged the rate stated at the time of purchase (plus applicable taxes) at the beginning of each billing period of your Subscription via the payment method that you have provided to Aureon Care. You are solely responsible for ensuring that your billing and payment information is correct to prevent your Subscription from being cancelled.

Prices and terms for Subscriptions may change at any time. The prices and terms in effect as of the Subscription Start Date or the date your Subscription last renewed (as applicable) shall remain in effect for the duration of the applicable Initial Subscription Period or Renewal Subscription Period (as the case may be), provided that new or modified prices and terms may apply to renewals or new Subscriptions. Aureon Care will provide you with reasonable notice of any updates or changes in prices or terms before they become effective. If you do not want to renew your Subscription under such new or modified prices or terms, you may cancel your Subscription as described herein.

All refunds of any pre-paid Subscription fees that you may be entitled to receive pursuant to these Terms will be credited to the then-current payment method associated with your Aureon Care account. Refunds are not based on account usage. If you terminate your Subscription and Aureon Care account for Aureon Care’s material breach of these Terms after providing Aureon Care with a forty-five (45) day cure period during which time Aureon Care fails or is otherwise unable to cure such material breach, Aureon Care will refund to you any pre-paid Subscription fees on a pro-rated basis.

Initial Subscription Period

Once your initial Subscription payment is processed, effective as of that date (the “Subscription Start Date”), your Subscription shall immediately commence, and you can access the applicable Services and Aureon Care Content. Your Subscription shall commence on your Subscription Start Date and continue to be effective for an initial period of twelve (12) months following your Subscription Start Date (the “Initial Subscription Period”). If you are a first-time Subscriber to Aureon Care, you may

cancel your Subscription after 3 months after your Initial Subscription Period for a full refund. If you are not a first-time Subscriber or if you cancel your Subscription after 3 months of your Initial Subscription Period, you will not receive a refund of any kind or for any amount, but you shall continue to retain access to the applicable Services and Aureon Care Content for the remainder of your Initial Subscription Period, after which your Subscription will be cancelled.

Automatic Renewal of Subscription

If you do not cancel your Subscription within your Initial Subscription Period and you elected monthly billing upon initial Subscription, then your Subscription shall renew automatically for additional, successive one (1) month periods (each, a **"Monthly Renewal Subscription Period"**), and your Subscription shall continue on a month-to-month basis as described herein until cancelled in accordance with these Terms. During any Renewal Subscription Period, you may cancel your Subscription at any time prior to the five (5) day period before the next Subscription renewal date, provided that you shall not be entitled to nor receive a refund of any kind or for any amount. If you cancel your Subscription at any time during a Renewal Subscription Period, you shall continue to retain access to the applicable Services and Aureon Care Content for the remainder of the then-current Renewal Subscription Period. If you cancel your Subscription at any time within the five (5) day period before the next Subscription renewal date, your Subscription shall renew automatically for one (1) additional Renewal Subscription Period, after which your Subscription will be cancelled.

If you do not cancel your Subscription within your Initial Subscription Period and you elected annual billing upon initial Subscription, then your Subscription shall renew automatically for additional, successive one (1) year periods (each, an **"Annual Renewal Subscription Period"**), and your Subscription shall continue on an annual basis as described herein until cancelled in accordance with these Terms.

7. Description of the Services

The Services include access to certain portions of the Site and certain proprietary services, and certain Services may only be accessible or used via the App. Unless explicitly stated otherwise, each new feature that augments or enhances the current Service shall be subject to these Terms. You acknowledge and agree that the Services are provided "AS-IS" and are based on the current state of healthcare technology and practice at the time of purchasing the Services. You acknowledge and agree that the form and nature of the Services which Aureon Care provides may change from time to time without prior notice to you, and that Aureon Care may stop (permanently or temporarily) providing certain Services (or any features within the Services) to you or to users generally at Aureon Care's sole discretion, without prior notice to you. You may stop using the Services at any time. You do not need to specifically inform Aureon Care when you stop using the Services unless you are requesting closure of your account. Aureon Care assumes no responsibility for the use of Services in any manner not contemplated by these Terms, or any use of the Services in violation of these Terms.

In order to use the Services, you must obtain Internet access, either directly or through devices that access web-based content, and pay any service fees associated with such access. You are solely responsible for paying such service fees and obtaining all equipment necessary to make such Internet connection, including a computer and modem or other access device. You are solely responsible for providing such equipment. Aureon Care is not responsible for the payment of any medical fees or co-pays associated with some of the Services.

8. The Aureon Care Mobile Application

License Grant

Subject to these Terms and your compliance with these Terms, Aureon Care grants to you a limited, personal, non-transferable, non-assignable, non-sublicensable, non-exclusive, terminable and revocable license to: (i) download and install the App on a single personal mobile device owned or controlled by you (or, if you downloaded the App from the Apple App Store, on any Apple-branded product running the iOS operating system that you own or control); and (ii) access and use the App as described in these Terms solely for your own personal, non-commercial purposes in accordance with these Terms and the Aureon Care Policies. No license is granted to any third party and you have no right to make available to anyone access to the App or the Services. Except as otherwise provided in these Terms, you have no right or license to use the App or Services for the benefit of another. You do not have any rights beyond what is granted to you in these Terms. Aureon Care reserves all rights not expressly granted to you in these Terms.

Consent to Collection and Use of Technical Data

By accessing and using the App, you expressly acknowledge and agree that Aureon Care may collect and use technical data including, without limitation, data concerning your mobile device, application software and peripherals to facilitate the provision of updates and other support to you, and for product improvement and quality assurance purposes. Any collection and use of such technical data is governed by our Privacy Statement.

Errors, Bugs and Updates

You acknowledge that the App is provided on an "AS IS" basis and may contain errors. Aureon Care does not and will not give any warranty or guarantee regarding the App or whether the App will be available or operate without error. Aureon Care will not be liable if, for any reason, all or any part of the App is unavailable. Aureon Care does not guarantee uninterrupted access to the App or availability of the App. You acknowledge that your access to the App may be interrupted for scheduled or emergency maintenance purposes, to fix bugs, for security, or other reasons. Access to the App may also be interrupted for reasons outside of Aureon Care's reasonable control. You acknowledge that the App and any information made available via the App may contain errors, including typographical errors, inaccuracies, and omissions. Aureon Care reserves the right to, at any time without notice,

correct any such errors, inaccuracies, or omissions, and to change or update any information offered on or through the App.

You acknowledge that the App has not been developed to meet your individual requirements and that it is your responsibility to ensure that the App as described on the applicable app storefront and in these Terms meets your requirements. You acknowledge that internet transmissions are never completely private or secure. Aureon Care cannot guarantee the confidentiality or integrity of any documents, reports, materials, content, information or data sent or received via the App. This means that any document, message, information, and data you send using the App may be read or intercepted by others, even if there is a special notice that a particular transmission is encrypted.

Updates to the App

From time to time Aureon Care may make updates available to you to improve the App's performance, to fix bugs or provide patches, to address security issues, to enhance, add or remove features or functionality, and/or to improve the user experience or make alterations to functionalities, with or without notice to you. Aureon Care may require certain updates for continued use of the App on your mobile device to address security threats. Aureon Care reserves the right at any time and from time to time to modify or discontinue, temporarily or permanently, the App (or any part thereof) with or without notice. We undertake no obligation to update, amend, or clarify information on the App, except as otherwise provided herein or required by applicable law. No specified update or refresh date applied on the App should be taken to indicate that all information on the App has been modified or updated.

Based on your mobile device settings, when device is connected to the Internet either: (i) the App will automatically download and install all available updates; or (ii) you may receive notice of or be prompted to download and install available updates. You must promptly download and install all updates when made available to you and you hereby acknowledge and agree that the App or portions thereof may not properly operate if you fail to do so. You further acknowledge and agree that any and all updates shall be deemed part of the App and be subject to these Terms.

No Medical Advice

You acknowledge and agree that neither the App nor any of the Services offers medical advice. Any content or data accessed through the App is for informational purposes only and is not a substitute for the professional judgment of health care providers in diagnosing and treating patients. Aureon Care, its licensors and service providers are not responsible for the accuracy, timeliness, or completeness of your Personal Information, or for any reliance by you or any medical professional on your Personal Information within the App, if any. Aureon Care is not responsible for any health care provider's reliance or non-reliance on your account or any other reports, materials or data (including any Personal Information) generated or otherwise made available by or through the App (including any use thereof) or through any use of the Services, or the accuracy thereof. **Please consult your doctor before performing any tasks or activities based on information provided or made available to you through the App. Please consult your doctor before taking any supplements or drugs based on information**

contained in your App or any other reports or information provided or made available to you through the App.

By downloading, accessing or using the App, you expressly acknowledge and agree that:

- The App is not intended to be a replacement for medical consultations from your doctor; and
- The App is intended to be used only as a tracker for care management, including remote patient monitoring and chronic care management for patients enrolled in applicable Medicare programs.

9. Risks and Considerations Regarding the Services

We encourage you to speak with your medical doctor or other health care professional prior to taking any action so you can make an informed decision about whether the intended action is right for you. A medical doctor can help you understand your results and options. You should not assume that any information we may be able to provide to you, whether now or in the future, will be welcome or positive. 10. Your Use of the Services

In consideration of your access to the Services, you expressly covenant and agree:

- To comply with all Aureon Care Policies and applicable laws with regard to your use of the Services;
- You will not use the Services for any purpose that is unlawful or prohibited by these Terms;
- You will not impersonate any person or entity, including, but not limited to, anyone affiliated with Aureon Care, or falsely state or otherwise misrepresent your affiliation with a person or entity;
- You will not obtain or attempt to obtain any materials or other information through any means not intentionally made available to you or otherwise provided for your personal use of the Services;
- You will not add your own headers, forge headers, or otherwise manipulate identifiers in order to disguise the origin of any content transmitted through the Service;
- Not to resell the Services or to resell, reproduce or publish any content or information made available by or through on the Services, except as explicitly described in these Terms;
- Not to upload, post, email or otherwise transmit any material that is derogatory, defamatory, obscene, or offensive, such as slurs, epithets, or anything that might reasonably be construed as harassment or disparagement based on race, color, national origin, sex, sexual orientation, age, disability, religious or political beliefs, or other statutorily protected status;
- Not to display, distribute, license, perform, publish, reproduce, duplicate, copy, create derivative works from, modify, sell, resell, exploit, transfer, or transmit for any commercial purposes, all or any portion of the Services, use of the Service, or access to the Service, except as otherwise permitted under these Terms or pursuant to a separate written agreement between you and Aureon Care;
- Not to circumvent, disable or interfere with any security features of the Services or other features that prevent or restrict use or copying of any content or enforce limitations on use of the Services or the content therein, including, without limitation, by use of any manual or automated software, devices, scripts bots, crawlers, spiders, data miners, scraping or other automatic access tools;
- You will not use the Services in any manner that could damage, disable, overburden, or impair the Services or interfere with any other party's use and enjoyment of the Services;
- You are responsible for all use of the Services made via your account, and you will contact us if you suspect that your password or account has been breached or used without your authorization;
- violate these Terms, any Aureon Care Policies which may be applicable for any particular area of the Service or have been communicated to you by anyone affiliated with Aureon Care.

11. User Covenants and Representations

By accessing the Services, you agree to, acknowledge, and represent as follows:

- You understand that information you learn or receive from Aureon Care or through your use of the Services is not designed to independently diagnose, prevent or treat any condition or disease or to ascertain the state of your health in the absence of medical and clinical information.
- You understand that the Services are intended for research, informational and educational purposes only and any information you learn or receive from Aureon Care or through your use of the Services should always be confirmed and supplemented by additional medical and clinical testing and information received from your medical doctor or other health care professional.
- You acknowledge that Aureon Care urges you to seek the advice of your medical doctor or other health care provider if you have questions or concerns arising from any Medical Information.
- You are eighteen (18) years of age or older if you are providing any Medical Information.
- You are aware that some of the information you receive may provoke strong emotion.
- You take responsibility for all possible consequences resulting from your sharing with others access to Medical Information and your Self-Reported Information.
- You understand that all your Personal Information will be stored in Aureon Care databases and will be processed in accordance with the Privacy Statement.
- You have the authority and capacity, under the laws of the state or jurisdiction in which you reside, to make the representations and be bound by the covenants provided in this Section.

12. Services Offered by Third Parties

We may offer you the opportunity to purchase products or services from companies other than Aureon Care. Use of those services will be subject to the terms and conditions of the companies offering the applicable products or services. Please read those terms carefully. You expressly acknowledge and agree that we make no representations or warranties, express or implied, with respect to such third-party products or services and we have no responsibility or liability whatsoever with respect to such third-party products or services.

Your correspondence or business dealings with or participation in promotions of information providers, vendors, and/or resources found on or through the Services, including payment and delivery of related goods or services, and any other terms, conditions, warranties, or representations associated with such dealings, are solely between you and such information provider or resource. You acknowledge and agree that Aureon Care shall not be responsible or liable for any loss or damage of any sort incurred as the result of any such dealings or as the result of the presence of such information provider or resources on the Service.

The Services may provide links to other websites and resources on the Internet. You acknowledge and agree that Aureon Care is not responsible for the availability of such external websites or resources, and Aureon Care does not endorse and is not responsible or liable for any content, advertising, products, services or other materials provided on or otherwise made available from such websites or resources. You further acknowledge and agree that Aureon Care shall not be responsible or liable, directly or indirectly, for any damage or loss caused or alleged to be caused by or in connection with

use of or reliance on any such content, advertising, products, services or other materials available on or through any such websites or resources.

13. Content and Materials Used in the Services

Aureon Care Content

All text, graphics, user interfaces, visual interfaces, photos, videos, documents, records, indexes of content, trademarks, logos, sounds, music, artwork and computer code (collectively, the **"Aureon Care Content"**), including, without limitation, the design, structure, selection, coordination, expression, "look and feel" and arrangement of such Aureon Care Content, contained on or made available through the Services is owned, controlled or licensed by or to Aureon Care, and is protected by trade dress, copyright, patent and trademark laws, and other intellectual property rights, proprietary rights and unfair competition laws. Except as expressly provided in these Terms, no part of the Services and no Aureon Care Content may be copied, reproduced, republished, uploaded, posted, publicly displayed, encoded, translated, transmitted or distributed in any way (including "mirroring") to any other computer, server, website or other medium for publication or distribution or for any commercial enterprise, without Aureon Care's express prior written consent.

You may use information on the Services (such as knowledge base articles and similar materials) that are purposely made available to you by Aureon Care for downloading through the Services, provided that you: (1) not remove any proprietary notices from any copies of such materials; (2) use such information only for your personal, non-commercial informational purpose and do not copy or post such information on any networked computer or broadcast it in any media; (3) make no modifications to any such materials and information; and (4) not make any representations or warranties relating to such materials or information.

User Content

When you use the Services, you provide us with different types of information. For an explanation of Personal Information and a description of the types of Personal Information you may provide to us, see our Privacy Statement. License to User Consent
